



## Parish Council Meeting Minutes

Thursday 19<sup>th</sup> June 2025 Cantley Village Hall at 7.30pm

1. Welcome and apologies for absence received from Norma Knight.
2. There were no declarations of interest in items on the agenda or requests for dispensations
3. The minutes of the Extraordinary Parish Council meeting held on 5<sup>th</sup> June 2025 were approved as an accurate record of the meeting. All agreed.
4. Public Open Forum. Report from the District Councillor hadn't been sent but will be covered at the next meeting.
5. There were no matters arising from the minutes not on the agenda: for information only
6. **Cantley Village Hall**
  - a. The Village Hall Committee have restated their request for Parish Council funding towards the rebuild project via a Public Works and Loan Board loan taken out against the Precept. After lengthy discussion it was resolved that the proposal is out of proportion to the size of the Council and the current precept. It was proposed to refuse the request to raise £130,000 over 50 years but consideration could be given to a smaller amount after a public consultation. Council were not minded to carry this out until such time as a more proportionate proposal with accompanying figures, is put forward.
  - b. A grant towards grass cutting for 2024/25 at a total cost of £905.00 was approved. All agreed.
7. **Staithe Charity**

An update was given regarding land and lease matters and further advice is awaited from Community Action Norfolk to determine how to proceed.
8. **Limpenhoe Village Green**

It was resolved to enact Standing Order 10:a:xi as information has now become available regarding the legal matters relating to the village green. It was agreed to therefore move this item to the end of the meeting and propose an exclusion under the Public Bodies (Admissions to Meetings) Act 1960. (please refer to item 15 below).
9. **Highways and Transport**
  - a. There was nothing report regarding Highways
  - b. The SAM2 report for May 2025 was received.

## 10. Dog Waste Bin – Limpenhoe

The cost of installing the post ready for the bin to be mounted was not available and Council resolved to give the Clerk delegated powers to arrange the installation of the bin. All agreed.

## 11. Asset of Community Value

- a. It was considered whether the Council wanted to nominate Cantley primary school estate as an Asset of Community Value (ACV). After discussion it was proposed that this should be proceeded with and brought back to the next meeting for approval.
- b. It was proposed that there may be other assets in the parish which may benefit from an ACV nomination. It was proposed that the matter is deferred for further consideration.

## 12. Finance

- a. The bank reconciliation to 31<sup>st</sup> May 2025 was received. The total balance of both accounts is £20,721.34.
- b. Payment of the nplaw invoice at a cost of £73.70 +VAT was approved.
- c. The cost of replacing the Clerk's laptop was considered. Issues with the slowness of the machine have been ongoing but following some storage maintenance it has improved. It was
