- 1. Welcome and apologies for absence received from Norma Knight and Jan Davis who is attending a Broadland District Council committee meeting.
- 2. There were no declarations of interest in items on the agenda or requests for dispensations
- **3.** The minutes of the Parish Council meeting held on 17th July 2025 were approved as an accurate record of the meeting. All agreed.

4. Public Open Forum

Reports received from the County and District Councillors were presented.

5. Matters Arising

There were no matters arising from the previous minutes that are not on the agenda.

6. Limpenhoe Village Hall

A request from the village hall committee for a grant to help with funding CCTV at the hall, following an incident of vandalism, was considered. It was proposed that an application be made via the Council's Grant Policy to include all relevant policy documentation required by law with the installation of CCTV.

7. Staithe Charity

An update on the progress with the Charity Commission application was presented by the Clerk. A missing lease agreement has been provided by British Sugar which has been forwarded to nplaw and Community Action Norfolk for review. Feedback is awaited.

8. Highways and Transport

- a. An update on matters reported to Highways. Feedback was given following a meeting with Tom Cox from Highways.
- b. The SAM2 reports for July and August 2025 were noted.

9. Community Resilience Plan

An updated version of the plan was presented for review. One amendment was requested relating to the Cantley Poor's Charity listing before it is published. A GDPR permission letter to be sent to all those listed with personal details to confirm permission to display the plan on the Council website. All agreed.

10. Church Grass Cutting

A request for information from the Parochial Church Council was considered. They had asked for an indication of how much the grass cutting grant will be for each church this year and how soon payment

can be made. It was suggested that presentation of a quote for the contract for the year would be acceptable in allowing the Council to consider their contribution.

11. Limpenhoe Village Hall

A duplicate agenda item. See item 6 above.

12. 2nd Brundall Scout Group

A request had been received from the group for a donation from CIL money towards the refurbishment of their facilities. Whilst Council considered this to be a worthwhile cause, the Council does not receive any significant amounts of CIL money so feel unable to make a contribution at this time.

13. Budget 2026-27

It was considered what projects should be included in the next years budget calculations. White gates on Manor Road and a possible concrete pad at the village sign for a new memorial bench have been put forward.

14. Social Media

It was proposed that the Council sets up a Facebook profile to share information with residents. After much discussion it was agreed that the Clerk should go ahead and set this up and run the page on behalf of the Council. A Social Media Policy will be drawn up for consideration at the next Council meeting.
